Local Navy Veteran Receives Kidney Transplant

Thanks to the efforts of a nonprofit organization and the generosity of a currently anonymous 40-something New Jersey man, a 77-year-old United States Navy veteran has his life back again.

On May 22, Henry "Hank" Goldberg, a resident of Tate Avenue in the Village of Buchanan, received a successful kidney transplant at Mt. Sinai Hospital and returned home three days later, well enough to wash the dishes.

"This is an amazing story," said Goldberg's wife, Viki. "Hank is now peeing like a 46-year-old. We are beyond feeling blessed. We have a sense of peace and gratitude."

Since learning six years ago that his kidney functions were not normal, Goldberg, a retired New York City correctional officer, and Viki have been researching all possible avenues that could lead to finding a kidney donor, the only permanent solution to his health issues.

They joined the federally-run United Network Organ Sharing (UNOS) program two-and-a-half years ago, which has a wait time in New York State for an organ match of five to seven years, and then learned about Renewal, a nonprofit group dedicated to assisting people suffering from various forms of kidney disease.

Indian Point Planning to Shut Down as Scheduled in 2021

Entergy is planning to shut down all its energy operations at the Indian Point nuclear power plant in the Village of Buchanan by April 30, 2021.

Responding to a recent call by state Senator Terrence Murphy (R/Yorktown) to delay the closing of the facility to 2030, Entergy officials appeared before the Cortlandt Community Unity Indian Point Task Force Thursday at Cortlandt Town Hall to stress the company's timetable to close up shop.

"Indian Point will retire as scheduled," said Mike Twomey, vice president of external affairs for Entergy. "We intend

to shut down as scheduled in the agreement. That is the plan everyone should expect to be implemented."

In January 2017, Entergy, which purchased the plants more than 15 years ago, announced, to the complete surprise of local leaders, its plan for the early and orderly shutdown of Indian Point Energy Center as part of a settlement with New York State and Riverkeeper. In exchange, New York State agreed to drop its legal challenges and support renewal of the operating licenses for the facility.

Units 2 and 3 at Indian Point generate approximately 2,000 megawatts of electric-

ity for homes, business and public facilities in New York City and Westchester County. This represents approximately 25 percent of the electric power used in the region. Unit 2 is set to shut down by April 30, 2020 and Unit 3 will follow suit a year later.

An emergency provision is included in the shutdown agreement that could give Entergy an additional four years of service in the event of war, a sudden increase in electrical demand or a sudden shortage of electric energy. However, Twomey

maintained those circumstances were highly unlikely to occur.

Instead, Twomey said the “biggest uncertainty” was the cost estimate for the decommissioning of the plants, which is expected to take between 10 to 15 years once its begins. Approximately \$1.7 billion is currently in a decommissioning trust fund controlled by Entergy.

The length of the decommissioning could tie up for years any potential property on the 240-acre site for possible redevelopment that local officials

have been exploring to replenish the \$32 million annual revenue Entergy provides to Cortlandt, Buchanan, Westchester County and the Hendrick Hudson School District.

Twomey said a good portion of the land could be utilized during the decommissioning process to store material, equipment and vehicles.

“We do not know what we will be using the parcels of the site for,” he said, noting about 125 acres will be needed to store spent fuel rods in dry cask storage.

“Until we have a plan, we don’t know.”

Regardless, Buchanan Mayor Theresa Knickerbocker, Hendrick Hudson Superintendent of Schools Joseph Hochreiter and Cortlandt Supervisor Linda Puglisi asked Entergy to consider setting aside some land for redevelopment.

“I think I have a pretty clear understanding of what we’re looking at,” said Knickerbocker, whose municipality will be losing half its operating budget once Entergy departs. “I understand we won’t be using the property in the very near future.”

Renewal representatives visited a synagogue in Teaneck, NJ one day seeking donors and five potential candidates emerged. One of those candidates specifically was interested in helping a veteran.

Six weeks ago, the Goldberg’s were contacted by Renewal and the required testing was performed. The operation was scheduled, but Viki said they were holding their breath since a kidney transplant procedure in March with a female donor was cancelled the day before.

“That was devastating,” Viki said. “Renewal never had that happen before. The

grief that we suffered from that was unbelievable.”

Last week, the operation with the New Jersey man took place without a hitch. Viki said Renewal volunteers stayed with her and Hank from 5:30 a.m. until Hank was in the recovery room at 6 p.m. The next day, Hank was walking around the ninth floor of the transplant unit.

While calling Hank Goldberg’s transplant “a wonderful story,” Rabbi Josh Sturm, Director of Outreach for Brooklyn-based Renewal, stated Renewal prefers “to keep a low profile” and declined to comment further.

Meanwhile, Viki Goldberg said while the operation was underway she took up a conversation with a woman in the waiting room for hours. That woman, she learned later, was the wife of Hank’s donor.

“What do you say to someone who has

given you the gift of life?” Viki said.

Once Hank clears the six-month mark of having no complications with his new kidney, Viki said they plan on taking a vacation on a riverboat the entire length of the Mississippi River.

Q: What’s behind the trend toward later parenthood?

A: Women in the U.S. are waiting longer than ever to have children, according to the Centers for Disease Control and Prevention. In fact, the average age of first-time mothers is now 26, up almost two years since 2014. In the last 10 to 15 years, we’ve seen the average age of first-time mothers increase greatly, mainly because women are pursuing careers and education first.

Q: I’m turning thirty. Should I be worried about my “biological clock” ticking?

A: The best time for a woman to get pregnant is between the ages of 20 and 35. In this age range, you are most fertile and least likely to experience complications. Though there is a slight risk of declining fertility by the age of 35, it’s only about 5 percent. Egg quality and quantity decline after age 35, and good ovulation cycles become less frequent. Eggs of poorer quality are released, making it more difficult to get pregnant.

Q: Will older moms-to-be face risks?

A: A mere twenty to thirty years ago, the maternal age of 35 was considered advanced for childbearing; it was also considered the age at which a woman became – virtually overnight and automatically – a high-risk pregnancy. Today we know that if you’re a healthy 35-year-old woman

who is pregnant, you may often have the same degree of risk in pregnancy as that of a younger mom-to-be.

If you’re over 35 and considering pregnancy, you may have to visit your physician more frequently to ensure that the pregnancy is proceeding smoothly. I recommend scheduling an appointment for both preconception counseling and genetic counseling. This will help your physician identify and minimize any risk factors so you can improve your chances of a healthy pregnancy. Women over 35 can deliver healthy children and have a safe pregnancy. It’s all about taking care of yourself, knowing your risks and coming up with a plan that is right for you and your family.

Q: I’m worried that when I do decide to have children, I won’t be able to. What are my options if I can’t get pregnant?

A: Advances in technology help many women over 35 get pregnant and give birth to healthy babies. In vitro fertilization is a process by which a woman’s eggs are extracted and combined with a sperm sample, creating an embryo that is transferred to the woman’s uterus. In vitro fertilization now includes a procedure called pre-implantation genetic diagnosis that helps identify chromosomal and genetic abnormalities, ensuring physicians are implanting healthy embryos.

Veterans Advocate Rips Councilwoman for Not Saying Pledge

During two separate Memorial Day ceremonies, a prominent veterans' advocate harshly criticized a Peekskill councilwoman for her stance not to say the Pledge of Allegiance.

William Nazario, a Lance Corporal in the Marines during the Vietnam War, a Purple Heart recipient and chairman of the Cortlandt Hudson Valley Veterans Committee, first let his feelings known Friday about Councilwoman Vanessa Agudelo at the Muriel Morabito Community Center in Cortlandt.

"How dare she? She not only disrespected me but everyone who has ever put on a uniform to fight for the freedoms we enjoy, for those who shed blood for this nation, for those missing in action," Nazario said to thunderous applause from fellow veterans.

"I don't care what anyone says about this country. It is by far the best in the world," he continued. "If it's so bad, I'm not stopping you from leaving. Freedom is not free."

On Monday, at Monument Park in Peekskill, this time with Agudelo standing about 10 feet away, Nazario again lambasted the first-year Democratic elected official, maintaining in her position she is held to a higher standard.

"This is not the message we want to

send to our young people. I consider it an unpatriotic cancer not to recite the Pledge of Allegiance," he remarked. "This is something that has to be stopped before it gets any further. I feel disrespected. I will not stand for it."

Agudelo was first openly taken to task about her stance at an April 23 Peekskill Common Council meeting by outspoken resident Leesther Brown and also was criticized by former Mayor Frank Catalina in a Facebook post.

After Monday morning's Memorial Day ceremony, Agudelo, who politely

clapped for Nazario when he spoke, said it wasn't the day to address the issue about the Pledge of Allegiance.

"He has every right to his opinion," she said. "I appreciate his service and everything he has done."

The only detailed remarks Agudelo has made concerning her reasoning for refraining from the Pledge of Allegiance were in an email last month to Examiner Media, in which she stated she was "a proud member of the Hudson Valley Democratic Socialists of America and a proud environmentalist."

"My reason for respectfully refraining from saying the Pledge of Allegiance is not because I don't respect the values this country stands for, it is because of our country's failure to truly uphold them I," Agudelo stated. "I have the utmost respect for our service women and men, both overseas and in the states, and I have a deep appreciation for all the sacrifices they have had to make. I do not think our country does enough to address the many challenges our veterans face after coming home from war nor is our country transparent enough about the hundreds, even thousands of lives lost fighting wars that most Americans do not or have not agreed with."

"There is also this level of unquestionable loyalty and mindless conformity in reciting the pledge on such a consistent basis that makes me personally feel uncomfortable," she continued. "Many people do not know that our pledge was originally written by a socialist in 1892, that there have been several versions of our pledge since its creation, or that the 'under God' was not added until almost a century after, used as a political ploy during the Cold War. Most countries in Europe don't even have a pledge of allegiance or have discontinued its use. This speaks volumes."

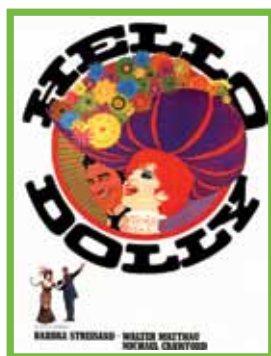

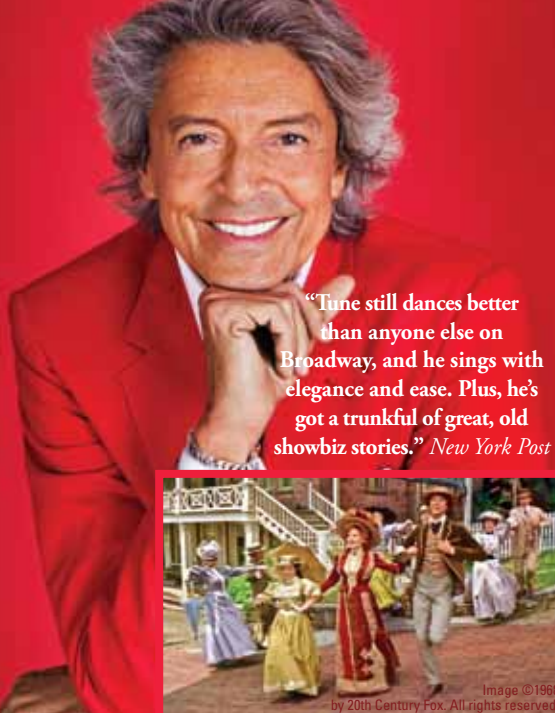

Yorktown Landmarks Preservation Commission to Host Event

The pre-revolutionary home of Dr. Murray Brennan in Yorktown will be the site of a reception hosted by Yorktown's Landmarks Preservation Commission on June 10 from 4 to 6 p.m. to celebrate National Preservation Month. Brennan's home and its accompanying barn, as well as the pond and dam on his property, date from the late 18th century. Known at the time as Hallock's Mills, the prop-

The H.O.W. Approach Yorktown

Portchester resident Michael Anzovino, owner of the H.O.W. Approach in Yorktown, has been helping local residents with their health and fitness for years.

Last week, Anzovino explained the acronym portion of the name of his business stands for “healthy, ongoing, wellness.”

Anzovino moved H.O.W. to Yorktown about two-and-one-half years ago. He moved to his current Underhill Avenue location about a year ago.

“We do personal training and chronic illness exercise therapy,” Anzovino said, adding his business specializes in working with clients with Multiple Sclerosis, as well as doing nutritional counselling.

He is the northeast ambassador for the MS Fitness Challenge. “It’s a way to give back to the community,” Anzovino said. For his clients with MS who cannot afford his services, Anzovino provides 12 weeks of free training. A new challenge will begin in June, he said. “It’s allowing those with Multiple Sclerosis to know that there’s other avenues. That there’s ways to be taught on how to manage

their symptoms, change their diet, get physically active,” he said. “They don’t have to be tied to the Multiple Sclerosis. It doesn’t have to define them.”

An example of how Anzovino has helped someone who has MS is the story of Garrison resident Maret Asaro. She came seeking the help of Anzovino several years ago. Anzovino told her that he did not have much knowledge of MS, but was willing to work with her. “Now I strictly train her for triathlons,” he said. “She’s been doing it going on four years.”

Anzovino said he works with each client differently, based on their needs. “We start somewhere and then we build off of that foundation, because I have to constantly reassess you,” he said.

The physical training is done at

Anzovino’s facility and he also gives his clients physical “homework” tasks and helps them improve their nutrition. “A big part of it is the education, what you need to do, why we’re doing things,” he said.

Anzovino said he trains his clients in a variety of forms of exercise including weight training, and calisthenics, he said. “You name it, we’ll do it,” he said.

Anzovino also refers his clients to other specialists, including a person who prepares food that will be brought home for those who have difficulty cooking, an acupuncturist, a chiropractor, a physical therapist, and a message therapist.

Working with persons with MS and other illnesses is gratifying, Anzovino said. “It’s the reason why I do it,” he said. “One of the things I tell most people is I want my business to get to a certain place, so I can work with the people that really need it for nothing. I don’t want to charge them.”

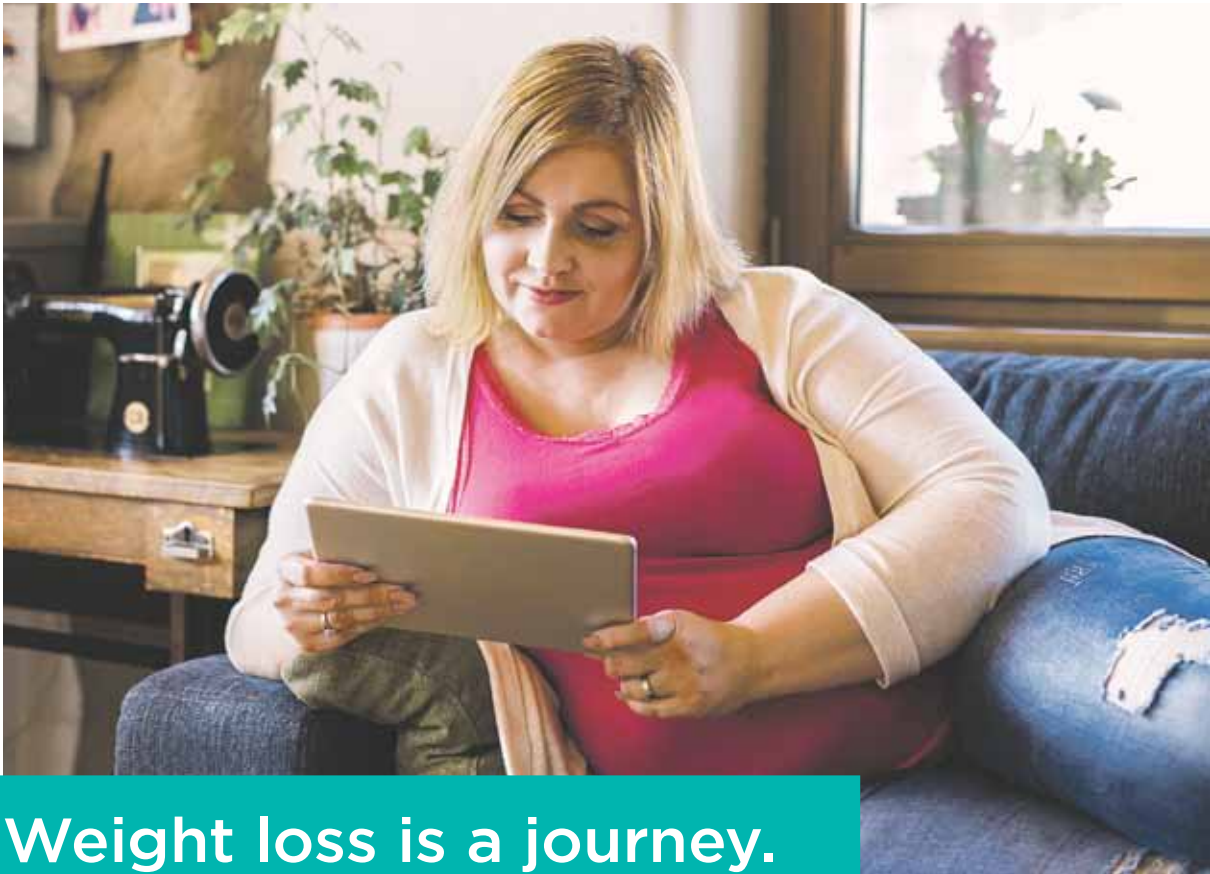

We Save Stuff and More Stuff, But Where to Put It?

Our homes are where we eat, sleep, play, sometimes work, and store things we've finished using but somehow can't bear to throw away. There are many reasons we may want to hold on to stuff we no longer need, but where do we put it all?

Granted, some homeowners achieve living on the light side where nothing is hidden and what you see is what you get. Or, they've gotten religion just before the sale of a home. The homes on the market which show best are those where all the traditional storage spaces – the attic, basement, garage and large closets -- are bare.

When I owned a single-family home, my attic and garage looked like storage rental facilities, but not as neat. When my wife and I prepared to sell our home a while back, we hired a crew to clean out our basement which had been packed with stuff from cement floor to beams overhead. There was clear evidence there of many different careers and lifetimes, including those of our parents and grandparents, along with tools and leftover materials from house renovations.

One of the workmen took me aside and told me how dangerous it was to

have saved enamel paint and paint thinner so close to the boiler. As the Home Guru, I was embarrassed. At first, it was a visceral experience to instruct the workers what to throw out for bulk pick up day.

My propensity to hang on to stuff started young. Maybe I had thought that someday I would be so famous that future generations would want some piece of who I was and what I did in life. But since I turned out to be just an ordinary guy, I really had no excuse.

It all started when I was an adolescent and my mother gave me a white envelope on which was written, "My Son William's First Haircut, Aged 2." Inside were Titian red curls that bear little resemblance to my hair today (or to anyone else's in my family, actually, causing my father to exclaim, upon first seeing me, "What's THIS?").

That was the first item I tucked away in a sturdy cardboard box that originally housed Florida oranges we would receive each Christmas from my Aunt Helen. Through the years, that box accommodated all my other official documents from my birth certificate to a special blessing from the Pope (my wife had

connections) when my wife and I married. Since then, that one box has multiplied like loaves and fishes.

By the time I was a teenager, I was collecting books and phonograph records before the time of downloading audio files, never thinning them out and always saving them. (Anybody want a rare collection of impressive 33 1/3 rpms from the 60s?) By the time I married, I went on to photography well before the days of digital images. I documented every move my family and I made, starting with our honeymoon.

Then my wife and I started collecting things together and, by the time we got into the antiques business part-time, the floodgates opened. We never got to the point of hoarding, and our house was always tidy, but we never really organized our storage of the things we didn't have room to display.

Perhaps as homes get downsized, efficient storage will be even more important, and today, there are many resources for creative solutions to tucking things away.

The Internet and large box retailers such as The Container Store are rich with the tools needed to store things properly. Home Depot boasts Martha Stewart's cubbies and closet kits, as well as a full assortment of containers for the garage

or outdoor shed.

For those who need industrial strength help with storage, there is always the great PODS concept (www.pods.com). Where the company will deliver a POD to a private home for "temporary" storage during house renovation, or preparing for a move, I have seen them stay on properties seemingly indefinitely, and there may be some local ordinances discouraging that.

If I were to dispense any advice about storage, it would be as simplistic as to suggest that we should all better manage what we collect in the first place.

As for my wife and me, we were forced three years ago when moving to a condo to downsize our "stuff" to fit into a reasonably sized storage cage. It was very liberating.
