

Fox Lane's Running Game is Too Much for the Quakers

It's no secret the Fox Lane football team will be relying heavily this year on the dynamic duo in its backfield — Andrew Brown and Michael Washington.

Neither of them disappointed on Friday evening when the Foxes made the short trip to rival Horace Greeley for the opening game of the 2018 season.

Brown rushed for 210 yards and three touchdowns, while Washington added 160 yards and a pair of scores as the Foxes defeated the host Quakers 34-22. By halftime, both of them had found the end zone twice as Fox Lane overcame an early one-point deficit and built a 27-8 advantage.


"The two running backs, I knew they'd have good games," said Fox coach Bill Broggy. "You can see, when they're healthy, they're tough to tackle. And then one can carry the ball three times, take him out, and the other kid can carry it three times. So if they run fresh, that's pretty good."

"You know what they're running and it's still tough to stop," said Greeley coach Joe Kearns about the victorious Foxes. "They do a real nice job with it."

It was Washington who provided the Foxes with their first points of the new season, bursting up the middle for a 22-yard touchdown just three and a half minutes after the opening kickoff. The point-after kick by Spencer Rowley gave Fox Lane a 7-0 lead.

The Foxes soon threatened again, moving the ball in five plays from their own 49-yard line down to the Quaker 26. But a turnover gave Greeley possession at its own 17 with 3:27 left in the first quarter. Seven plays later, quarterback Seth Brail connected with Danny Meringolo for a 30-yard touchdown pass.

On the two-point-conversion try, Brail rolled to his right and tossed the ball to Ethan Samkoff, who made a sliding catch in the right corner of the end zone, giving Greeley an 8-7 edge with 20.5 seconds

remaining in the period. But the Quaker lead didn't last very long as Washington soon scampered 47 yards on first down to the Greeley 13-yard line, setting the stage for Brown to run left for a nine-yard touchdown on the opening play of the second quarter that gave Fox Lane the lead for good.

Fox Lane added to its lead when Brown scored from seven yards out exactly halfway through the second quarter to cap an eight-play, 56-yard drive. The PAT try sailed wide to the right, but the Foxes still had a 20-8 advantage.

When a Quaker drive stalled at the Fox Lane 22-yard line with just under three minutes left in the half, the Foxes took advantage and built a commanding lead. They needed eight plays to march the 78 yards to the end zone, the last four coming




The Foxes' Michael Washington changes direction as he carries the ball during the 34-22 win over Greeley.

on Washington's second touchdown, this time a four-yard run with 26 seconds to go. The point-after kick gave the Foxes their 27-8 halftime cushion.

The Quakers managed to get a bit closer midway through the third quarter as Brail tossed a 19-yard touchdown pass to Jacob Rose. But the point-after try was blocked and Fox Lane later regained its three-touchdown lead when Brown scooted left for a 21-yard touchdown on the first play of the fourth quarter to conclude an 11-play, 80-yard drive.

The final touchdown of the night was scored by the Quakers with just over two minutes remaining. Brail threw over the middle to Meringolo for a seven-yard score and then passed to Rose along the left sideline for the two-point conversion that narrowed Greeley's final deficit to 12 points.

"Right now, we've got to lick our wounds and get back out there on Sunday," said the Quakers' Kearns. "But we're gonna be alright. We're gonna win some games this year. We had a few players that definitely opened up my eyes with their toughness and a couple plays they made. That's always good to see. Clay Dealy, he stepped in there and made a couple plays for us and showed his toughness. And our quarterback, Seth Brail, he took a couple licks and he kept saying, 'I'm fine Coach.' That's a tough quarterback right there."

Despite the victory, Fox Lane's Broggy walked off the Quaker turf with a few concerns, most notably his team's lack of depth.

"A win's a win," he said. "I'm proud we won, but some sloppy stuff. We've got a lot of work to do. I don't think any coach after the first game is gonna say, 'Oh, everything's fine."

Panthers Open the New Season With a Disappointing Loss

It hasn't even been 10 months since the Pleasantville football team captured its first-ever state championship.

But on Saturday afternoon at Parkway Field, that unforgettable late November day for the Panthers sure seemed like a long, long time ago.

Hosting Ardsley High School in the 2018 season opener, the defending state champions surrendered touchdowns early and often, falling behind 28-0 by halftime en route to a humbling 34-6 defeat that provided a bitter reminder a good chunk of last year's talented and exalted roster was lost to graduation.

"We obviously weren't prepared for the type of game Ardsley brought," said disappointed Panther head coach Tony Becerra afterwards. "Maybe we could've gotten away with it with a lesser team, but not against a team as good as Ardsley."

The visitors jumped ahead three minutes into the game as quarterback Frankie Belarge tossed a touchdown pass to Brett Loccisano to cap a 74-yard opening drive. When Pleasantville fumbled the ball away on the ensuing kickoff, Belarge wasted no time adding to the Ardsley seven-point lead. He found wide receiver Vincent Manzi open down the right sideline and hit him in stride for a 43-yard scoring strike. The point-after gave Ardsley a 14-0 margin with 8:40 still to go in the first quarter.

Pleasantville answered by moving the football down to the Ardsley 34-yard line, but on a fourth-and-four play a long pass by Jack Howe over the middle to Danny Melillo was overthrown. Ardsley then proceeded to march 66 yards on seven plays, scoring with 14.5 seconds left in the quarter as Preston Wachtell somehow caught an up-for-grabs Belarge toss in a crowd in the left side of the end zone.

"Nothing that happens Week One surprises me, whether the score was the other way or it was close because that's just the way Week One always is," said Becerra, whose reeling Panthers found themselves trailing by 21 points after just one quarter.

A 22-yard pass from Howe to Melillo on the last play of the first period set the Panthers up at the Ardsley 48-yard line. But six plays later, facing third and nine, Howe spun away from pressure in the pocket and then floated a pass that was easily picked off by Manzi, who returned the interception to midfield.

Ardsley was unable to take advantage of the Manzi interception, but certainly did late in the half following another one by Loccisano deep in Pleasantville territory. Howe's third-and-19 pass from the 4-yard line was returned by Loccisano just shy of the goal line and, one play later, Jalen Leonard-Osbourne ran in for his team's fourth touchdown.

"In Jack's defense, routes weren't run correctly and blocking wasn't there," said Becerra about the opening-game struggles of his star quarterback. "He was just trying to make something happen out of nothing."

Trailing 28-0, the Panthers had possession of the football to start the third




Pleasantville fullback Harrison Hailsworth carries the ball in the Panthers' season opener against visiting Ardsley.

quarter. But any notion of a miraculous second-half comeback disappeared on the second play from scrimmage. Howe threw to his right, but the pass was intercepted by Manzi, who ran 33 yards for yet another Ardsley touchdown. Thought the PAT sailed wide, Pleasantville's deficit was suddenly 34-0.

The lone highlight of the afternoon for the Panthers came 90 seconds into the final quarter when Howe got to the outside and raced 66 yards down the right sideline for Pleasantville's first touchdown of the new season. Howe's long TD run provided something for the home fans to finally cheer about, but was far too little and late to change the outcome.

"We're not a complete team yet," said Becerra. "It's what we're striving for. We're not there yet. The goal week to week is improvement, whether we won this game or lost this game. Whether it was close or a blowout like it was, the goal was always

to improve."

The disappointing start was magnified even more by the presence, for the first time, of the Panthers' new, oversized state-championship banner on display at the north end of the field.

"Yeah, well, maybe it should come down," said Becerra, perhaps not in jest. "That's the other big thing this week. We've just got to separate ourselves from last year and find our own identity. We're still searching for that and we're still striving to be a more complete team. Obviously we got knocked down and let's see how we pick ourselves up and how we move forward."
